Format	100% online — 7 courses (176 lessons), optional weekly live workshops with replays, private community

Accelerated pacing is possible with strong availability — typically 3 to 6 months, never under 3 — and access to the course content itself is lifetime.

What is included

- A dedicated instructional-design mentor and 2 strategic planning meetings (goal setting and a flagship project kickoff)
- Feedback on 3 full-build projects: develop 3 project ideas and complete 3 full builds
- Resume feedback from your instructional-design mentor
- Weekly live feedback workshops (optional, with replays) and full access to all 7 courses
- Portfolio feedback, custom tools built for students, and the private student community

Tuition and payment options

Option	Amount
Up-front	\$7,400 (saves \$500 vs. the payment plan)
18-month plan	18 monthly payments of \$438.89 — \$7,900 total

On a payment plan you agree to make all 18 payments even if you finish sooner; there are no early-payoff fees, and custom shorter plans keep the same plan total. Credit-card payments add a 3% surcharge.

A refundable \$550 deposit reserves a seat for a future start and is applied to tuition — on a payment plan it counts as the final payment. No deposit is required when enrolling immediately.

Applying is free. Applications are reviewed within 3 days, and enrollment links are valid for 72 hours.

Refund policy

You may cancel for a full refund within 7 days of enrolling by emailing support@peckacademy.com. From enrollment through week 18, refunds follow the prorated weekly schedule in the School Catalog. After week 18, Practitioner tuition is not refundable.

Note

On an 18-month payment plan for a 9-month program, payments lag tuition liability, so a withdrawing student is typically not eligible for a refund.

Start dates

Cohort start dates are published in the School Catalog's school calendar. Different cohort names do not mean different programs — the content is identical in every cohort. Depending on team availability, you may also be able to start immediately.
